**Youth Hi Point:** Points from 1-22; to be eligible, must show in class 12 or 15

**Ladies Hi Point:** Points from 5, 6, 7, 8, 9, 11, 13, 15, & 21; to be eligible, must show in class 9 or 15

**Mens Hi Point:** Points from classes 3, 5, 6, 7, 8, 11, 17, & 21; to be eligible, must show in class 3 or 18
